THE PHOENIX FARM MARKET IS PROVIDED TO THE COMMUNITY AS A SERVICE OF THE FIRST UNITED METHODIST CHURCH ("SPONSOR") ON LANDS OWNED BY THE VILLAGE OF PHOENIX AND LICENSED FOR SUCH USE TO THE SPONSOR BY CONTRACT WITH THE VILLAGE. ALTHOUGH THE VILLAGE IS NOT A CO-SPONSOR OR OPERATOR OF THE FARM MARKET, THE CONTRACT AND THIS APPLICATION, UPON ACCEPTANCE AND APPROVAL BY SPONSOR, IS SUBJECT TO CERTAIN FARM MARKET RULES AND REGULATIONS APPROVED AND SUBJECT TO MODIFICATION BY THE VILLAGE AT ANYTIME. AMONGST OTHER THINGS THE VILLAGE RETAINS ULTIMATE AUTHORITY OVER SUCH RULES AND REGULATIONS AND THEIR ADMINISTRATION IN ORDER TO ENSURE THE LEGAL USE OF PUBLIC PROPERTY. THE VILLAGE IS NOT OTHERWISE INVOLVED IN MANAGEMENT, ADMINISTRATION OR APPROVALS/DENIALS OR CONDITIONING OF PERMITS. THE SOLE REVENUE RECEIVED BY THE VILLAGE IN CONNECTION WITH THE FARM MARKET IS A PERCENTAGE OF THE FEES PAID FOR SPACE USE. THE VILLAGE HAS DETERMINED THIS FAIR AND REASONABLE CONSIDERATION FOR THE LIMITED USE OF VILLAGE LANDS. ASIDE FROM THAT PERCENTAGE REMITTED BY THE SPONSOR TO THE VILLAGE, MARKET SPACE FEES PAID HEREUNDER ARE THE PROPERTY OF SPONSOR AND HAVE BEEN DEEMED BY VILLAGE TO BE A FAIR AND REASONABLE COMPENSATION FOR ADMINISTRATION OF THE FARM MARKET.

PLEASE NOTE: The 75% requirement shall be determined by Sponsor applying a criteria comprised of weight, area, volume and or any other reasonably based criteria intended to ensure the Farm Market good and product line is reasonably perceived as, and as well is comprised of 75% homegrown goods and products at each vendor space. The Sponsor's determination in this regard shall be final provided it is based on written articulated grounds (including as a Permit condition) and such criteria and grounds are substantially similar enough to those articulated in other determinations of the Farm Market to not be arbitrary or capricious. If and to the extent same are not determined to be at least 75% homegrown, home-baked or homemade, a permit may not be approved or revoked, or continuation may be conditioned upon compliance.

I (we) further agree to operate my (our) space in accordance with the Farm Market Rules and Regulations and to pay all applicable fees as set out in the Farm Market Rules and Regulations. I (we) do understand that the space fee, length of season, and hours of operation are set in the Farm Market Rules and Regulations, and I (we) will abide by them.

I (we) further understand that failure to comply with the Farm Market Rules and Regulations may result in revocation of this Permit and the vacating of permitted space.

As a vendor, wishing to participate in the Farm Market, I (we) agree to defend, hold harmless and indemnify the Farm Market, the Sponsor, Village of Phoenix, and each of their respective, officers, directors, trustees, agents, members and employees whatsoever and without limitation, for and from any and all claims, liabilities or responsibilities, actions or suits arising from same and pertaining to injury or damages to person or property as a result of this permit, my/our use or occupation of the permitted space. I (we) verify that all information I (we) have provided about our goods and products for sale is and shall remain true and accurate.

I (we) understand that the Farm Market operates on limited funds. I (we) also acknowledge that the Farm Market's beneficial purpose will be frustrated if it is subjected to costly litigation. Accordingly, I (we) hereby agree that as a condition of participation in the Farm Market, I (we) will resort to litigation against the Farm Market, Sponsor and/or Village of Phoenix, their respective trustees, directors, officers, management, employees, agents and affiliated entities, only after first attempting in good faith to resolve any dispute with and through the Sponsor. We agree to advise the Village, in any event of any such claim or dispute and the particulars thereof at the same time as such notice is given to any other person or entity. Except as may be prohibited or restricted by law I (we) agree to limit any claim I (we) may have as a result of a decision by the Farm Market management, Sponsor or Village and which results in the denial, revocation, suspension or conditioning of a permit, including the denial of a product to sell, or wrongful suspension or termination, to a refund of any farm market permit fees incurred during my (our) absence from the market. I (we) further agree that in the event I (we) am/are unsuccessful in any litigation or other enforcement efforts against the Farm Market, Sponsor or Village, I (we) will pay all costs, expenses, fees, and disbursements incurred by the Farmers Market in the course of its defense of any such efforts, including litigation, and including any attorney's fees, statutory costs and disbursements incurred by such parties.
