Mayor Ryan Wood began the Board Meeting with a salute to the flag at 7:02 PM.

Miller Engineering

Doug Miller stated that the pump station is all set and next Tuesday is start up. Flushing will begin on August 28th. Waste water consent order is in place and they're working on the first two items due next week with the DEC the solid handling and sampling plan. Miller said last week a quarterly report was submitted on activities with the waste water and they had a positive response from the DEC. The CDBG grant administrative agreement is complete and signed and Doug is working on the engineering agreement.

Gary Knapp – Economic

A presentation was given by Mr. Knapp regarding economic development with industrial and residential opportunities. He will be providing the board with additional information soon.

Attorney Comments

Attorney Primo said that Barb Reyes was seeking to subdivide the .375 acre Phoenix Press property from the remainder of her property. The code allows for this and Primo suggested the code be expanded to permit less than 5 (ie. 4 lots or less) administrative subdivision. The board was receptive to a change in a minor subdivision provision Primo will be provide a local law.

Attorney Primo said there is an amended agreement for the Interfund agreement, credit facility agreement fund loans. Motion to approve the Interfund Agreement was made by Trustee Pendergast, seconded by Trustee Sweet. All ayes.

Mayor said with the switch over to OCWA he wants to send out a postcard for the flushing plan and also would like to put out the new rates in the next billing cycle. His recommendation is to raise the rate for water to \$2.00 per 1,000 gallons and we can always revisit the rates after this quarter. Motion to approve was made by Trustee Sweet, seconded by Trustee Pendergast, Mayor Wood aye, Trustee Musumeci nay. Motion passed.
