# **Department Comments**

Greg Shaffer, WWTP operator presented to the board his recommendations of compliance and upgrades for the collection system and waste water treatment plant. He also discussed the SPDES permit, the I & I issues at the plant relative to the water main break and our high flows, the time line and dates that are associated with the Village Engineer and the Village Attorney and their tasks. He discussed what tasks the Village has achieved and what is left. Greg also complimented on the DPW crew and a job well done on the November 26 water main break.

# **Mayor and Trustee Comments**

Mayor Wood updated the board on the CDBG grant, we received an email from EFC that said the Lock Street Project is fundable, but the way his interpretation of the email reads it does not give us authorization that it will be funded until their January meeting when thie full board can review it. Mayor has reached out to Scott LaMountain from CDBG, he wasn't able to connect with him yet but is letting him know where we stand, that we're on board with the project, we're moving forward with bonding, EFC believes it will be funded, they need to present it to their board for approval before they can give us the official okay. The contractor agreed that as long as the works starts by spring he is holding his price.

Trustee Griser said he wanted to thank Chief Nerber for inviting the trustees to participate in the Shopping with a Hero event, it was well organized and they did an amazing job. Griser also wanted to thank the DPW for working 22 hours straight to repair the water main break.

Trustee Musumeci also thanked the DPW for their hard work.

Trustee Sweet said it was a great time this weekend with Shop with a Hero and the DPW did a great

job.

Clerk Roxanne Demo said on behalf of Trustee Pendergast he'd like to update the local law for solid waste 161.11 penalty for bringing in garbage from the outside, currently it's a \$200 penalty and he'd like to change it to \$500.
