Department Comments

Chief Nerber said regarding the police reform he will have a discussion and review with what they've put together with Attorney Schiano in the next week. Also speaking with him Greg highly recommends to move to body cameras for the police department. Chief will research the cost in doing this.

It is of no use to us any longer, we insure it, there's an easement to enter the property, he's not sure what its worth but believes it something the board should look into now. Lynch asked Trustee Dunn whenever you're ready he'd like to meet with him to discuss the firemen's monument. He'd like to have everything ready to start working on for Spring.

Attorney Schiano

Attorney Schiano has sent the water agreement over to the Town and is waiting got hear back from them. He will touch base with Kevin Caraccioli the Towns Attorney this week. The Kline property should be done, we previously did the public notice for that property, he did draft the transfer document and deed, Mr. Kline has signed the documents it just needs to be filed now with the County Clerk's Office and that will be finalized as well. An update with the property with the bus in the front yard, so he did appear with the Town of Schroepel virtually, we spoke with the Judge and the violation we sited him with was corrected. Schiano indicated to the judge that there are several other vehicles on the property that are either are not registered or parked in violation of our village ordinance. He did indicate to the judge and the owner of the property we intend to bring new charges, new violations against him regarding the other vehicles on the property.
