Mayor and Trustee Comments

Mayor Borchik stated that we've received information from the Library's Attorney, they had a discussion on this and Mayor has asked to board to review.

We're getting set for the Floating Circus on August 20th from 7:00-8:30pm, if anyone would like to volunteer to help that would be appreciated.

Trustee McBurnie had nothing.

Trustee Maxam was pleased that the village looked good after the garage sale day.

Trustee Koegel thanked the DPW and the County for cleaning out the drains on Main St.

Department Comments

Chief Ferazzoli handed out July 16 – August 5 police activity report. Chief Ferazzoli introduced new PT Police Officer Alec Williams to the board. On August 8th at Henley Park they will be holding coffee with a cop at 9:00am, there also will be activities for the kids. Chief reported that the Narcan box has been placed on the Bridge St. side of the Medicine Place. We've received the new police vehicle, he'll be getting the graphics done as soon as he can.

Administrator Lynch reviewed the tree list that included removal and pruning of various tree for this year with the board. CHIPS this year we have \$108,844.73, of that \$74,259 will be spent on grinding, paving on Davis Street from Volney to Main and also Park Street. Also we're looking into a roller to purchase with approval from CHIPS. Lynch has a meeting next week with a vendor "Just Plane Fun", he's looking to hold a kite event on the island, he'll keep everyone updated. Lynch discussed with the board that some of the fire hydrants in the village should be replaced. He'll provide additional information on cost at the next meeting. The Town helped take down a dead tree on Elm Street for us, and they're going to help with another tree near the Library. Lynch provided the board with the comprehensive plan, DRI and NY Forward Grant application, it's important for us to make some adjustments ourselves. Mayor asked the trustees to read the whole document. The DPW will be working on two sidewalks this year from our list.

Attorney Comments

Attorney Schiano spoke about the WWTP upgrade, we have an updated IMA, one of the main issues is if there's a shortfall of funding or increase in project. The County isn't on board with the IMA, the IDA didn't show up for the meeting, the Town Attorney was there, that we're not moving forward at this point.

Attorney Schiano would like to board to review the Library packet, it's what we've been waiting for from their Attorney, it's an outline that they feel there are a municipal Library. A further discussion needs to be done.

Schiano said regarding the Enacting Local Law#2 – Zone Change for the property at 303.16-03-06 to change the property from resident one to business. He reviewed with the board the seeker that was prepared from Mike Lasall the Engineer for this property. Motion to accept the negative declaration as it relates to seeker was made by Trustee Maxam, seconded by Trustee Koegel, Trustee Hartner aye, Trustee McBurnie aye, Mayor Borchik aye. Motion carried.

Motion to approve Local Law#2 – 2025 Zone Change at 303.16-03-06 "Walts Property" subject to any comments from the County, was made by Trustee Maxam, seconded by Trustee Koegel, Trustee Hartner aye, Trustee McBurnie aye, Mayor Borchik aye. Motion carried.

The agreement between the Village and the Bridge House Brats is still being reviewed with their board.
