Mayor and Trustee Comments

Mayor Borchik asked for a motion to approve a resolution for himself, Jim Lynch, Roxanne Demo, Kristy LaManche (K&L Consulting) and David Powers (Barton & Loguidice) to execute the following contracts with NYS:C1003042 - Transform North Island into Canalside Entertainment Venue and Recreational Area, C1003043 - Expand Marketing Campaign for the Village, Including New Gateway and Wayfinding Signage, C1003044 - Expand Wastewater Treatment Plant and Upgrade Facilities, this includes signing contract documents, submitting MWBE forms, updating timelines for completion and revising work scopes, as needed.
