WHEREAS, a Local Law has been introduced before the Board, to wit: Local Law 2023-1,

entitled "A Local Law Amending Chapter 205, Table C Entitled "Required Parking Spaces"", the text of which is as follows:

LOCAL LAW 2023-1 AMENDING CHAPTER 205, TABLE C ENTITLED "REQUIRED PARKING SPACES" OF THE CODE OF THE VILLAGE OF PHOENIX

BE IT ORDAINED AND ENACTED by the Village Board of the Village of Phoenix, County

of Oswego, State of New York, as follows:

Bold italics is new language.

WHEREAS, the Village Board of the Village of Phoenix believes that Table C of Chapter 205 of the Village Code requires too many parking spaces for "Retail trade use and Eating and drinking establishment" and the number of required parking spaces should be reduced for those uses.

WHEREAS, by this local law, the Village of Phoenix desires to amend Table C of Chapter 205 of the Village Code to require one parking space per 200 square feet of gross floor area.

WHEREAS, a public hearing was held on March 7, 2023, in relation to Local Law 2023-1.

NOW, THEREFORE, BE IT

RESOLVED, that Local Law 2023-1 is hereby approved and enacted; and be it further

RESOLVED, that the Village Clerk is directed to file Local Law 2023-1 with the Secretary of

State within 20 days of the date set forth herein.

RESOLVED, that this local law shall take effect immediately upon the filing with the Secretary of

State.
