### **Mayor and Trustee Comments**

Mayor Borchik reminded everyone that Monday, September 11<sup>th</sup> we'll have our Annual 911 Ceremony at 6:30pm at Henley Park. Borchik said that we have 20 instances called double wood which is an old pole sitting next to a new pole. He received a call from the director of the public service commission of NYS, he has been working on this since April, the director has spoken with Windstream, Spectrum, National Grid, and he's given them two weeks to transfer their wires off the old pole to the new one so that the old poles can be removed. ## **Department Comments**

### Sergeant Ferazzoli

Sergeant Ferazzoli wanted to publicly thank Dave Dingman and Nick Duskee for their donation of \$750 each for the police boat. The boat was out September  $2^{nd}$ , for 5 hours and had 1 inspection. Vehicle and traffic enforcement has increased, 24 traffic stops, 15 local law citations.

Tomorrow's the first day of school and our school enforcement will be in full force. Ferazzoli said we have a new live scan booking station that's been installed.

### **Administrator Lynch**

Administrator Lynch updated the board on the zoning board meeting, it was a little confusing, and they only had two members. Attorney Schiano said the board will need to meet again, they did not have a quorum. A public notice will be sent out again, they need to have a quorum and there needs to be a public vote in the open meeting. Trustee Pendergast the liaison to the zoning board will contact Chairman Remington.

Lynch asked about the next step to form a water district for outside the village bounds but using our facility. Attorney Schiano said the next step is to contact the Town of Schroeppel they are the ones to create the water district. There was a discussion with regards to the band practicing early in the morning.

## **Attorney Comments**

Attorney Schiano said in the public hearing discussion there were some questions relating to penalties with the amended Vehicle and Traffic local law Chapter 190, he will update that in the next week. Schiano believes the code violation case with the chickens is settled, he's provided Lynch with photographs that the coops are empty. Attorney Schiano said they will discuss further the local law violations that will have to be prosecuted by the Village Attorney, he will discuss this with the Judge and we'll address this in the next week or two.
