# NY Forward Update - Moving The Village Forward

**Have you heard?** The Village of Phoenix is one of three communities in the Central New York region selected for the first round of the State's NY Forward program.

We received a \$4.5 million award to help identify and complete transformative and/or catalytic projects in and near our Canal Waterfront District downtown. The NY Forward program also provides robust technical assistance and capacity-building directly to communities throughout each phase of the program. Phoenix is paired with a consultant team that is providing this assistance and guiding our community through the planning process.

#### How can you get involved?

- Participate in our next public meeting, scheduled for September 12 starting at 5pm at White Pines Commons. Stay tuned for more information. We hosted our first public meeting in late June and the meeting presentation is available online for review.
- Attend a Local Planning Committee (LPC) meeting. These
  working committee meetings are open to the public to
  observe, with a public comment period at the end. Our
  next LPC is scheduled for September 28, starting at 5pm
  at White Pines Commons.
- Review previous meeting presentations and other

The NY Forward planning process started in May and will continue through Fall 2023 with the completion of the Strategic Investment Plan (SIP). The SIP will include a list of projects recommended for NY Forward funding by the LPC. A subset of the projects submitted in the SIP will be awarded funding by the State, with awards likely to be announced in early 2024.



The Village of Phoenix is a canal community rich with 19th century history and character. It is located within the Town of Schroeppel in southern Oswego County, New York and covers 1.145 square miles Lock 1 of the Oswego Canal, on the Oswego River, is located within the Village limits.

From 1750 to 1763, critical events in the French and Indian War can be linked to the Oswego River and surrounding waterways. British troops erected a small fort to protect ammunition and other supplies at the junction of the Oneida, Seneca, and Oswego Rivers, which is known as Three Rivers Point and is south of Phoenix. Eventually, the troops traveled along the Oswego River and past what is now the Village of Phoenix as they made their way to Fort Ontario.

The Oswego River system was then canalized and locks and dams were constructed to allow commercial shipping from the Atlantic Ocean to the Great Lakes via the New York State Canal System. With the marked success of the canal system, Hamlets and Villages were created alongside the canal. In 1846, the Village of Phoenix was incorporated. It was primarily an industrial hub, focused on the manufacturing of goods and services to be shipped along the canal to westernmost locations.

By the late 1800's, the Village of Phoenix had developed into a community rich in opportunity and cultural experience. In the late 19th century, several major fires reshaped the character and appearance of the Village. The Great Fire in 1916 was the most devastating, destroying 80 buildings. Most of the existing buildings along the Canal Waterfront District were built between 1917 and 1929. Beginning in the early 1920's, most of the industry left the Village and thus began the trend towards becoming the "bedroom community" that it is today.



Welcome to the Village of Phoenix, where the Oswego River flows through the center of the village providing a unique avenue for travel, recreation and a connection with our past. Whether you are a life-long resident, new to our village, or just passing through, we invite you to become a part of our extended family.

Our community boasts an ever growing business district along the Oswego Canal at Lock One, beautiful residential homes, fine schools, parks, library and our very own Bridgehouse Brats. The services provided by our government departments are unsurpassed. Public safety needs are provided through the Phoenix Police Department and the Enterprise Fire Company with skill and professionalism. Residents can take pride in the personal service and quality work provided by the Office of the Village Administrator, Clerk/Treasurer, Waste Water Treatment Plant and the Department of Public Works.

The Village of Phoenix is pleased to announce it was recently awarded \$4.5 million through the NY Forward Grant. After three years of applying, the village's hard work paid off as New York Secretary of State Robert Rodriguez presented the village with the award. 
Please be mindful of our crews working on the roads and children walking to school once school starts back up. Summer seems to be going fast and we will be preparing our equipment for the approaching winter season.
