Police Department News

Just a quick update on what your police department has been up

As a Village Police department we try to stay in touch with our residents and do so through community programs. This past fall we again trick or treated with about 25 adults and children in an effort to offer them a safe environment. I feel this was a success and am happy to continue this yearly. We also started the camera program last year and we really didn't have a large response so I am posting this again below in hopes more citizens will realize how important it is to share your videos with the police department.

I would like to announce a new program we have launched in an effort to help keep our Village safe and solving crimes more efficiently. We would like to invite our residents to register their in home security camera systems to include ring door bells. This is certainly not any instance of big brother and we are not asking to have access to your links or footage, it is simply a program to let us know where the cameras are to assist us in solving crimes. Technology is our friend and awareness is half the battle. Village trustee Brian Borchik has offered to help install new ring door bell systems to any resident that may be interested, please let us know.

On December 20th we recognized two of our officers and three community members at a ceremony held at the Sweet Memorial Building. Officer Brian Fortino received (first ever recipient) the Charles Moyer Community Service award for his commitment to programs such as Shop with a Hero and other worthy events. Officer Hunter Nerber was honored for his heroism for surviving a critical incident that took place in November. Also honored were David Dingman (The Medicine Place), Geoffrey Raponi (Fulton Walmart) and Jimmer Szatkowski (Chick-fil-A) for their ongoing dedication to our village in support of our programs.

December 20, 2022 the village board changed the overnight parking hours from 0200-0600 to Midnight to 0700. This took effect immediately to assist our DPW in keeping the streets clear to be able to efficiently remove snow, please help them out by not parking on the village streets between those hours.

Our crosswalks have caught a lot of attention lately, citizens are noticing that motorists are not stopping for pedestrians

attempting to cross at or in these crosswalks. We listened to those complaints and have been monitoring and issuing tickets for those violations. The village board has also become actively involved by improving the crosswalks with new signage and warning lights on Culvert Street. We ask that you help us keep our citizens and visitors safe by paying attention to our vehicle and traffic laws in our village. We also hosted one of our most successful and well received Shop with a Hero programs partnering with nearly every police agency in Oswego County, including the Oswego Youth Bureau and the United Way. We were able to help approximately 65 children for the holiday season.

We still have some challenge coins left that are for sale for \$10 each, the proceeds go to our community programs such as CHOOSE, KIND, and Shop with a Hero. They can be purchased at The Medicine Place on Main Street.

Gode Enforcement Update

Older neighborhoods especially need to rely on code enforcement to make sure that houses and buildings are maintained sufficiently to keep up property values and also to keep pace with new technologies and safety research.

While property owners often think that the way they take care of their property is their own business, the major impact that neighboring properties have on one another's value and enjoyment means that building maintenance and safety becomes the business of everyone in the neighborhood.

When you hear someone loosely talking about code violations and why the Village is not enforcing the codes, the first question to ask yourself as a neighborhood leader is whether the Village actually has adopted by ordinance a code that would cover the offending situation. If so, you might have a clear path toward making property owners accountable for maintaining their buildings (both the main building or house and any garages, storage sheds, and such). You also may have a way to deal with some ugly or inappropriate things people keep outdoors, although I must warn you that codes often does not address some of the worst aesthetic decisions that people make!

If your neighbor leaves their old sofa on the porch, and you don't like it, that doesn't necessarily mean it is a code violation. Your particular code would have to speak directly to the situation. Although there's a bit of personal judgment on the part of the inspector involved, it doesn't stretch far. Codes do not necessarily address everything that you might find offensive aesthetically. I hope you can appreciate that what you may think is an old sofa might be considered a quirky porch chair by your neighbor. In the end, codes will not address anything and everything you might find offensive, but we certainly strive to maintain a basic standard.

I mention these issues because of the things that I hear from time to time. We live in a nearly 175 year old Village of approximately 900 homes and a population of roughly 2,300 residents. Nearly all structures in our Village could be cited with some type of a code violation. After receiving this newsletter, I will strongly campaign to survey our Village for specific areas of concern such as, missing or non-color-contrasting house numbers, trash cans left by the road or visible from the street, trash put out to the curb too early, furniture, carpet and large piles of household items left by the curb, unlicensed vehicles, parking across the sidewalks and not keeping your sidewalks clear of snow and or debris.

Having this article in front of all residents is my way to say that based on what I have heard, this is what is going to happen and code violations will be written as opposed to what has generally been practiced as a "friendly reminder" letter. I realize we all have different situations, capabilities and means of performing some tasks, so should you have an issue with my plan moving forward, please feel free to contact me in my office at the Sweet Memorial Building or call my direct number at 315-695-1307.
